END USE CERTIFICATIONS

(1) We will not sell, export, re-export, divert or otherwise transfer any product or components (collectively, "Parts") to any entity or country, including but not limited to Iran, North Korea, Syria, Russia, Belarus, the Crimea, Donetsk and Luhansk regions, and Cuba unless authorized by the U.S. Government. If not shipping from the US, this also applies to the applicable selling country's respective debarred lists issued.

(2) We will not directly or indirectly sell, transfer, export, or re-export, transmit or participate in any export transaction involving Parts with individuals or companies listed on the U.S. Treasury Department's OFAC SDN list (or companies owned 50% or more by one or more SDNs), the U.S. Commerce Department's Table of Denial Orders, the U.S. Department of State's list of individuals debarred from receiving Munitions List items, and any other lists administered by the Department of State, Treasury or Commerce, the European Union, Hong Kong or other applicable lists, i.e., Entity Lists as well as Denied Person/Company lists of the selling country.

(3) We will not sell, export, re-export, or otherwise dispose of any Parts for: (i) use in activities which involve the development, production, use or stockpiling of chemical, biological, nuclear weapons, rocket systems (including ballistic missile systems, space launch vehicles, and sounding rockets) or unmanned air vehicles capable of delivering the same, or in development, production, use or stockpiling of weapons of mass destruction; or (ii) use in any facilities which are engaged in activities relating to such weapons or applications, without authorization from the U.S. Government if required by applicable law.

(4) We will not sell, export, re-export, or otherwise dispose of any Parts to China, Hong Kong, the Russia Federation ("Russia"), Belarus, Venezuela, Burma/Myanmar or Cambodia (i) for incorporation into a military item or for use that supports or contributes to the operation, installation, maintenance, repair, overhaul, refurbishing, "development," or "production," of military items and/or to the national armed services (army, navy, marine, air force, or coast guard), as well as the national guard and national police, government intelligence or reconnaissance organizations, or any person or entity whose actions or functions are intended to support "military end uses" as set forth in (i) in those countries.

(5) We will not sell, export, re-export, or otherwise dispose of any Parts for: (i) the "development", "production", operation, installation (including on-site installation), maintenance (checking), repair, overhaul, or refurbishing of a "supercomputer" located in or destined to China, Hong Kong, Macau or other D:5 country (collectively "D:5 Country"); (ii) the incorporation into, or the "development" or "production" of any "component" or "equipment" that will be used in a "supercomputer" located in a D:5 Country; (iii) the "development" or "production" of integrated circuits destined to a "facility" located or headquartered in or whose ultimate parent company is headquartered in a D:5 Country where we know "production" of "advanced-node ICs" occurs; or (iv) the "development" or "production" of integrated circuits destined to a "facility" located or headquartered in or whose ultimate parent company is headquartered in a D:5 Country where "production" of integrated circuits occurs, where such Parts are in Category 3, CCL Groups B, C, D, or E and we do not know whether "production" of "advanced-node ICs" occurs at such "facility".

(6) We will not directly or indirectly, sell, transfer (in country), export or re-export any Parts specified in ECCN 3A001.z, 3A090, 4A003.z, 4A004.z, 4A005.z, 4A090, 5A002.z, 5A004.z, 5A992.z, 5D002.z, 5D992.z or 3E001 (for 3A090), as amended, to or for: (i) any entity located in China, Macau, or any other country located in Country Groups D:1, D:4 or D:5 (excluding any destination also specified in Country Groups A:5 or A:6); or (ii) any entity, regardless of where it is located, if the entity is headquartered in, or its ultimate parent company is headquartered in a D:5 Country (e.g., a China headquartered cloud or data server provider located in Malaysia).

(7) We will not directly or indirectly sell, transfer (in country) export or re-export any Parts specified under ECCN 3B001, 3B002, 3D001, 3D002, and 3E001 to or within a D:5 country.

(8) We acknowledge that Huawei, Sugon, Hikvision and the Inspur Group, among others, are currently on the BIS Entity List and/or identified as a Communist Chinese Military Company on the NDAA. As such, all exports, re-exports and transfers of items subject to the EAR or under the Foreign Direct Product Rule to these companies will require a license from BIS.

(9) We will comply with applicable US and EU trade restrictions, especially the restrictions targeting Russia, Belarus, the Crimea, Donetsk and Luhansk regions. Further: (i) We shall not sell, export or re-export, directly or indirectly: (a) to the Russian Federation or for use in the Russian Federation any Parts supplied under our agreement that fall under the scope of Article 12g of Council Regulation (EU) No 833/2014, any other provision of the Council Regulation (EU) No 833/2014, or Regulation (EU) 2021/821 of the European Parliament and of the Council of 20 May 2021 setting up a Union regime for the control of exports, brokering, technical assistance, transit and transfer of dual-use items (recast), or in the Council Common Position 2008/944/CFSP of 8 December 2008 defining common rules governing control of exports of military technology and equipment. (b) to Belarus or for use in Belarus any Parts that fall under the scope of Article 8g of Council Regulation (EU) No 765/2006 or any other provision of the Council Regulation (EU) No 765/2006, or Regulation (EU) 2021/821 of the European Parliament and of the Council of 20 May 2021. (ii) We shall undertake our best efforts to ensure that the purpose of paragraph (9)(i) not be frustrated by any third parties further down the commercial chain, including by possible resellers. (iii) We shall set up and maintain an adequate monitoring mechanism to detect conduct by any third parties further down the commercial chain, including by possible resellers, that would frustrate the purpose of this paragraph (9)(i). (iv) Any violation of paragraphs 9(i), (ii) or (iii) shall constitute a material breach of our agreement, and we shall be entitled to seek appropriate remedies, including termination.

(10) Parts may be subject to U.S. Export Administration Regulations ("EAR"), as amended. As such, we will abide by all applicable U.S. and/or the applicable selling country export control laws and regulations for any Parts purchased. We will not export, re-export, import to any other country or transmit any Parts except in accordance with all applicable laws, regulations, and, if applicable, the terms of any license or licenses issued by any applicable government authority. We understand that Data Power Supply is a U.S. person and agree not to cause Data Power Supply to facilitate the shipment, transmittal, transfer or servicing of items for prohibited end-uses in violation of §734.9, §744.23 and §744.6 of the EAR, as may be amended from time to time. We will also comply with the International Labor Organization's conventions on forced labor.

(11) We certify that the information provided herein is true and correct and that the representations and certifications shall survive the term and termination of the relationship between us and Data Power Supply.
